For everyone's safety, it is imperative that we have enough lifeguards on duty to cover both the beach and any off-lake guests that will be attending your party and planning to swim. Please let us know ASAP if you would like to reserve the grove so that we have time to secure the proper lifeguard coverage. This is for the safety of all members as well as off-lake guests and is also a requirement by law. If we are not able to secure enough lifeguards to cover both the beach and your party, swimming may need to be restricted on the day of your party. When planning your party, please also keep in mind that lifeguard availability is limited after August 15th.

Fees:

- **Rental Fee:** \$50 check due at time of booking
- **Security Fee:** \$100 check due at time of booking (returned after passing inspection)
Without the security fee being paid, the grove will not be reserved for you.
- **Guest Swimming Fee:** \$5.00 per guest if swimming (ages 5 and up)
This fee is non-refundable unless the party is cancelled within 2 weeks of the event date or for inclement weather.

Guidelines:

1. Take trash out to the 4 dumpsters behind the Lodge.
2. Leave the grove area as you have found it.
3. ***The morning of your event, place a small sign at the grove including the Member name, date, and time of the event. Picnic tables on the patio are for your use; picnic tables on concrete (by boat lockers) are for use by any Member.***
4. On the day of the event, please introduce yourself to the lifeguards on duty. This gives all parties a point of contact during the event. The lifeguards will also be giving you wristbands for your swimming off-lake guests.

You will receive wristbands for all guests to wear. There are gas grills and charcoal grills available in the cove for your party (please bring your own propane tank and/or charcoal and lighter fluid). These are for use by any Member and are not reserved for parties at the grove.

I as a Member of High Crest Lake Lodge, Inc. hereby understand and agree to the rules and regulations governing the rental of the grove as part of HCL property. I understand and agree that I am responsible for all grove property and must be present during the set-up, clean-up and duration of the affair.
